CONTINUING CREDIT AGREEMENT

THE APPLICANT HEREBY AGREES TO THE TERMS AND CONDITIONS SET FORTH HEREIN.

- 1.) The applicant hereby authorized Adobe Lumber, Inc. to investigate any references herein listed or statements of other data obtained from me or from any other person pertaining to my credit or financial responsibility.

- 2.) All accounts are due and payable by the 25th of the calendar month following the statement date. If that date is on a Saturday, Sunday, or Holiday, then the account is due and payable on the closest working day prior to the 25th of the month. A 1% discount will be allowed if payment is received by the 10th of the month following the statement date, provided no prior invoices are past due. Any invoices not paid by the 25th of the month, following the statement date will be considered "PAST DUE". A finance charge of 18% annum, 1.5% per month, will be charged on all amounts past due.

- 3.) Should suit be commenced and attorney's fees be incurred to enforce payment of this account or any portion thereof, the prevailing party shall be entitled to recover costs of suit and reasonable attorney's fees.

- 4.) If Adobe Lumber, Inc. accepts any payment after the date it is due, that acceptance does not affect the due dates of any other amounts on the account, nor will it act as an extension of time for payments of any amounts then remaining unpaid. It will also not modify any of Adobe Lumber's rights under this agreement. Any sale, transfer, or subjection of the materials to any encumbrance or failure to make a payment when due shall constitute an event of default, Adobe Lumber, Inc. shall be free to exercise all remedies permitted under state law including, but not limited to, repossession of materials.

- 5.) In the event of default by Purchaser under this Agreement, Adobe Lumber, Inc. may immediately declare the entire unpaid balance of the account due and payable.

- 6.) The terms and conditions set forth in this Application constitute a complete and exclusive statement of the agreement between Adobe Lumber, Inc., and the Purchaser. Any oral agreements or understanding to the contrary shall be of no effect. The terms and conditions of this Account can be modified only by written amendment signed by an authorized person at Adobe Lumber, inc., and Purchaser.

- 7.) Security interest in materials: Purchaser hereby grants Adobe Lumber, Inc. a purchase money security interest under the Uniform Commercial Code ("UCC") on all merchandise purchased on this Account until paid for by the Purchaser. Purchaser agrees to sign, upon request, any financing statement (UCC-1), and any other instrument, document or papers and to do all acts Adobe Lumber, Inc., may require to protect or encumber said materials until such time as Purchaser's performance under this Agreement is completed. Purchaser is responsible for any loss of damage to the materials until the price is fully paid.

- 8.) Applicant will provide seller, upon request, complete job information on all orders of \$1,000.00 and over for the purpose of preparing and serving a California Preliminary Notice.

- 9.) Those persons signing this application and shown on this credit application, individually and as officers of any corporation applying herein, do agree to the terms and conditions of this contract; and individually do guarantee the payment for all materials and services purchased pursuant to this agreement.
